#### **Discussion 2: Infrastructure & Servicing**

## **Aspects Discussed:**

## **Transport**

- VPA & Council will need to arrange discussions with VicRoads and PTV, who did not attend the workshop
- Council Infrastructure team was widely in agreement with VPA in regard to the results of the traffic study, further clarification and investigation needs to be made once council and VPA have met with VicRoads and PTV.

#### **Schools**

- Consensus amongst agencies and council that there is a need/gap in the north east of Warrnambool for an additional primary school.
- Catholic Education flagged an interest in the site however will need to confirm numbers and DET's position in regard to the PSP.
- Glenelg Hopkins CMA flagged general concern for school which has been approved without proper consultation with the CMA
- Catholic education was open to the idea of colocation of schools with DET if necessary
- Agencies and council generally agreed with the principle of colocation of child care facilities and community infrastructure in general

#### Drainage

- Wannon Water discussed the need for a new pump station to service the site, preferably to be located at the lowest point of the site, and possibility to locate in conjunction with open space
- Wannon Water flagged the need to build a water tower in the north west corner of the precinct, both to service the future precinct site and neighbouring developments. Wannon water also discussed the possibility of colocation with open space
- Wannon water support the concept of roof top water harvesting and would be interested in discussing further the possibility of how this would work.
- Wannon water flagged that there are mains pipes that feed of the water storage ponds to the south of the precinct which would need to be considered in the FUS and road network designed accordingly.
- CMA was unsure about the proposed embankment which was discussed in the drainage background report and trigger issues with ongoing maintenance of the embankment and the ramifications for the water way as a whole.

### Services (electricity, gas, telecommunication)

- Powercor explained that while they would be willing to be involved in any renewable programs, however will not lead the program.
- Sustainability Victoria flagged that they would be able to put council and VPA in touch with alternative energy providers to discuss the possibilities on the site.
- Wannon water mentioned that they have has experience with solar farms on their sites and would be potentially open to further discussions around the use of their sites for solar energy.
- Gas and Telecoms agencies did not attend meeting and further consultation from council and VPA will be needed
