 - Please note the wording under 1.5.1 ("We proudly acknowledge...") is preferred over those on page 1. Please consider updating page 1 to reflect this section.
- 3.1.2 Requirements and guidelines viable densities
 - R. 4 will there be exemptions to this requirement? What if cultural heritage is identified at the back of these lots, and a Proponent cannot fully consider S61 considerations due to this requirement?
- Table 15 Strengthened community....
 - o Please correct WWWCHAC to WWCHAC
- Plan 7 can the conservation area be included on the legend?
 - The *note at the bottom of the legend should this read "further inviestgatios of potential stony rises at these locations [required]"?

 - O What is "scattered tree" in the table on page 3 (of 4)?
 - Please include a specific Condition regarding Aboriginal Cultural Heritage and areas of Cultural Heritage Sensitivity. The Wurundjeri Cultural Heritage Unit is able to assist in the development of this condition.
- 14. Particular Provisions in Clause 52.17
 - Why is a permit NOT required for removal (remove, destroy or lop) of native vegetation in a conservation area? The Cultural Heritage Unit Elders request this is removed (and requires a permit).
- 15. General Provisions in Clause 66.04
 - Please include "relevant Registered Aboriginal Party" to the proposed amendment to subdivide land containing the conversation area <u>alongside</u> DEECA.
