Subject: 1031 Beatty's Road Grangefield's VIC 3335

I write as owner of 1031 Beatty's Road Grangefield's identified as Property 74 in the Melton East Precinct Structure Plan and state my objection to much of my property being classified/proposed as the Water Way and Drainage Reserve under the land budget in the PSP which is explained below.

When I purchased the property in early 80s, it was being used for Grazing and small farm activities. I have owned the property since 1983, in my time of owning the property it has been used for grazing and small farm activities. There is a home in the northwest corner and that is where I live, and a man-made dam in the northwest corner. As identified in the PSP there is a natural depression covering approximately 10 ha of the site. However, this depression is very rarely damp or retains water. It is highly degraded and mostly covered with thistles and invasive species. In addition:

- this site was mapped under the MSA in 2012 which concluded that it could be developed on the basis the relevant values are offset by way of a payment (attached relevant MSA report).
- The Rakali Report 2013 notes that "not classified as SHW but still considered as significant is the Plains Swampy Woodland/Lignum Swamp Complex component of K6".

So, whilst there may be small environmental value here (which I doubt now given the level of degradation), there is framework in place (MSA) which has not identified them as significant enough to be maintained or managed in a conservation reserve.

I highlight this because of my 29.68 ha approximately ~26ha or the property or 87% has been required/proposed for drainage. However, only 10 ha is identified as a historical wetland.

I believe this proportion reserved for drainage is very high and does not serve the need of the future community? I also believe the required percentage should be around 30% of my land reflecting the depression area with a wide belt around it, as most of the land around that depression is elevated and blend nicely with its surrounding plains.

The location of my land being close to the proposed Rockbank north town /shopping centre makes it ideal to serve the need of the future communities by utilising it for medium density mixed use of housing types and community facilities

In accordance with Melbourn Water Development services scheme Principle 16, the value of the land will be based on the undeveloped broad acre land value at the date of the offer, recognising the underlying development potential of the subject land. As such, I submit that my property is mostly developable and would only be inundated because of urbanisation. So, I should be fairly compensated for the area that would otherwise be developable.


