As requested, Powercor's position regarding potential land for the future Avalon Zone Substation remains unchanged. As discussed over the phone earlier today, I'm confirming in writing that Powercor's preferred land locations for the future Avalon Zone Substation are **Sites 1, 2, 3, and 4**, in that order of priority.

Sites 1 and 2 are considered the most suitable, followed by Sites 3 and 4. These locations align with our planning, technical, and environmental requirements and will ensure the substation can effectively support future network development within the Greater Avalon Employment Precinct.

The approximate coordinates of the preferred sites are as follows:

- **Site 1:** -38.041678, 144.430340
- **Site 2:** -38.056430, 144.428075
- **Site 3:** -38.036122, 144.431838
- **Site 4:** -38.057307, 144.445311

Maps showing the indicative locations are attached for reference.
